StarChase

StarChase is a less-than-lethal vehicle tagging system developed early in 2006 to tag, track and locate a fleeing vehicle. This technology was previewed to the PCSC in 2017 and StarChase was included in our preferred pricing program. Since 2017 there was no activity or interest shown in the program, however, recently there has been renewed interest. Vanessa Hregdovic will do a 15-20 minute refresher presentation on the technology.
